
Office leasing

Chinese staffs human resources outsourcing and agency

In an enterprise, the local staff employ not only saves HR cost, the local team but also will become the backbone force in China market. Of course, the employ is not a simple salary payment. Same as Like most countries in the world, Chinese government makes a labor and social security system also. The employers have to handle the fussy employment processes and pay for social insurance. Any nonstandard behaviors will cause punishments and indemnity. The HR services provided by us reduce the law risk, and to the enterprises who hire less than 50 staffs, our HR services reduce the cost of company.
